EMP & CxA Credentials Approved for Work in San Francisco's Commercial Buildings Program

In response to a request from EMA Headquarters, administrators at San Francisco's Department of Environment reviewed the Energy Management Professional credential and have included it in their <u>list of certifications that are qualified to perform audits under the San Francisco Existing Commercial Buildings Ordinance</u>. As part of the same request, ACG's CxA certification was reviewed and also included on this list (see link).

San Francisco's Existing Commercial Buildings Ordinance applies to existing commercial buildings with 10,000 square feet or more of space that is heated or cooled. The Ordinance has two separate requirements: energy benchmarking and energy audits. Information and links to more detailed information can be found on the <u>Ordinance homepage</u>.
