

### What the Tax Bill may Mean for Energy Efficiency

The greatest impacts, both positive and negative, will likely come from the broad changes to taxes and revenue. Some companies will have more money to spend on efficiency improvements as a result of the tax cuts; others less. The deduction for state and local taxes will be capped, which could make it more difficult for state and local governments to fund efficiency upgrades and programs.
